Sir,

I beg to acknowledge the receipt of your letter of the 16th instant, from which it appears that the land that you squatted on is L.S. 9, 10, 14 & 15, of Section 31, Township 23, Range 18, West 6th Meridian. The land being under reserve at the present time, no entry can be granted. When the Department decides to grant entries the public will be notified and the land dealt with according to the regulations that are then in force. According to the practice of the Department, an entry will not be granted for portions of two quarter-sections, and I would advise you to confine your improvements to one quarter-section. A plan of the township with the Timber Berths outlined in blue, you will find enclosed. Thomas Alton appears to be the only homesteader within the Township.


