Early drop off is not available. Parents are asked to drop their children off and leave museum grounds before camp starts at 10 am, as the presence of parents can be a distraction. Please remember to pick up your child(ren) promptly and inform the staff if anyone else will be picking up your child. We start and end each day at the **Brisco Schoolhouse on the Museum Grounds.**

Please provide your child(ren) with 2 snacks, a bagged lunch and water bottle, a hat, and a **swimsuit and towel** each day. There will be water activities daily if the weather is nice.

Also, please be informed that we do have mature fruit-bearing bushes and trees on the property which we do allow the children to eat. Occasionally, campers will get treats provided by the museum, including freezies and home-made Ice Cream. If you know of any allergies or sensitivities your child(ren) may have, please make us aware.

Registration Policy

Registration is on a first-come, first-served basis. Once registration is confirmed by email, the Golden Museum and Archives will issue an invoice. Payment is due upon receipt, unless other arrangements have been made. If payment is not received, registration will be canceled and waitlisted children will be offered the spot.

The Golden Museum accepts cash, credit, debit, and e-transfers.

Cancellation Policy

In case of cancellation for any reason not related to an emergency, a refund will only be issued if the spot can be filled. All reasonable attempts will be made to fill spots when notice of 10 days or more is provided. A non-refundable \$20 cancellation fee will be charged for all cancellations, unless the cancellation is considered an emergency.

If for any reason the Golden Museum cancels your session or the minimum enrollment is not met, you will receive a full refund, or, if you prefer, the opportunity to transfer to another session if space is available.

Field Trip Policy

While the Takin' It Back to the Future Summer Camp identifies the Golden Museum as its home base, activities often happen off museum grounds. These trips include, but are not limited to, visits to parks and playgrounds, the swimming pool, Kicking Horse Movies and Ice Cream, the Rotary Trail and Dike area, and the Field Town Site.

I, the undersigned, authorize the Golden Museum's staff to accompany my child(ren) off Museum grounds. I also authorize my child(ren) to be transported to offsite facilities by Mount 7 Taxi, when necessary.

Behaviour Issues Policy

Golden Museum wishes to protect the safety and welfare of all Takin' It Back to the Future Summer Camp participants. In order to maintain a safe and fun environment our camp staff may implement various techniques to manage occasional misbehaviour. For example, a time out may be used to allow time for a child to regain their composure or they may lose the privilege to participate in an activity. Depending on the severity of the negative behavior, parents may be asked to pick-up their child early from camp, but only after the issue has been discussed with the Executive Director or the Museum Manager.

If the camp leader documents extreme or recurring negative behaviour that is considered to be endangering other participants or excessively disruptive to the operations of the camp, the Camp Coordinator will meet with the parent(s)/guardian(s) to discuss the behaviour issues and the child may have to leave camp. Negative behaviour includes, but is not limited to:

- uncooperative behaviour, such as not listening to camp staff and not respecting the rights of others;
- repeatedly running away from the camp staff or volunteers;
- theft or vandalism;
- hitting, biting, fighting, or other violent behaviour.

The Golden Museum reserves the right to remove students who do not adhere to our behaviour policy. In this instance, no refund will be given.

Smoky Skies Policy

The Golden Museum acknowledges that wildfire smoke has become an inevitability during the summer. Our camp staff will implement alternate activities when wildfire smoke is too heavy to do regular outdoor activities. During times of extreme smoke physical activities will be limited to 20 minutes or less at a time, as per health guidelines. Please note that the regular cancellation policy applies to weeks with smoke coverage, and smoke does not count as an emergency unless a medical condition, such as asthma, is indicated upon registration.

Photography Policy

During the course of our programs, we often take photos and video of people enjoying their visit. We use these pictures and film to help secure grants and to advertise Golden Museum History Camps to families.

This is to inform you that the Golden Museum has the irrevocable and unrestricted right and permission to copyright – in their own name and otherwise – and use, re-use, publish and re-publish photographic images taken at any Golden Museum facilities: Golden Museum and its enclosed area, Brisco Schoolhouse.

By participating in the Takin' It Back to the Future Summer Camp programming at any or all of the facilities listed above, you and your child may be included in part or in whole in any and all media now and hereafter know for illustration, promotion, art, editorial, trade, web-site, advertising or any other purpose deemed appropriate by Golden Museum without compensation.

If having your child's photograph/video taken and/or displayed is not a safe option for your family, you need to notify staff prior to the commencement of the session to determine whether Golden Museum can accommodate your request to not have pictures/video taken or if it would be best for your child not to participate in this program.

We understand the need for safety and privacy of tender-aged children, and are committed to making all attempts to use photos that do not put children at undue risk, including avoiding photos where children are easily recognizable, or photos could be considered immodest, e.g. bathing suits.

Emergency Authorization

In the case of an emergency, Golden Museum staff will make every effort to contact the parents or designated emergency contact. If these contacts cannot be reached, I authorize Golden Museum to obtain emergency medical treatment for the welfare of my child. I will be responsible for medical expenses incurred. The staff at the Golden Museum is not authorised to give out medication. If your child needs medication during their time at camp you need to make arrangements to attend the camp to administer it yourself.
